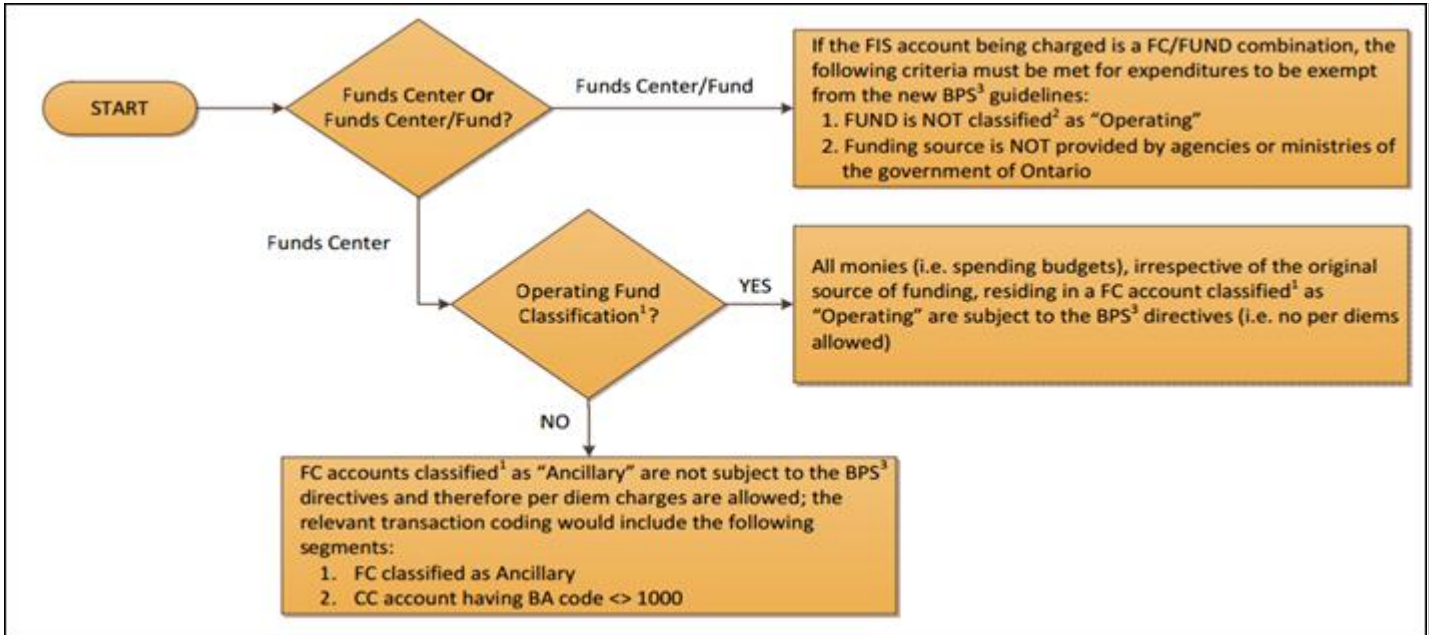

Is my Funding Source Subject to the Ontario Broader Public Sector (BPS) Guidelines?

The Ontario Broader Public Sector directives (instituted in January 1, 2012) are a set of guidelines that direct how **Broader Public Sector (BPS)** organizations such as the University of Toronto **can procure goods/services or reimburse expense claims when the source of funding is the Ontario government.**

Typically, this is the case when the funding source is indicated using an **Operating Funds Center** or a restricted Fund provided by the Ontario government (e.g., Ontario Centres of Excellence (OCE), Ontario Genome Institute, Ontario Mental Health Foundation).

To determine whether the BPS guidelines govern your funding source, take a look at the following decision tree:
