FIS users, with AMS Posting Access, can use the ERDD -Web application to create and/or post expense reimbursements for individuals within their department.

# How do I process an FIS payment for a Scotiabank Visa Travel & Hospitality Card?

Departments can make payments directly to **Scotiabank** on behalf of the cardholder via FIS. Please ensure the entire **16-digit account number** is entered in the Reference field to avoid delayed payments and delinquency charges.

# Adding an 'Alternative Payee' address after an invoice has been processed (but not cleared)

After an invoice has been processed, **you can add an Alternative Payee** to redirect the cheque to an alternate address **as long as the payment has not cleared**.
